



Software License Agreement

This legal document is an agreement (this "Agreement") between you, the end user ("LICENSEE"), and ENCORP, Inc. (hereinafter "ENCORP"). IF LICENSEE USES ANY OF THE PRODUCTS, LICENSEE AGREES TO BECOME BOUND BY THE TERMS OF THIS AGREEMENT, WHICH INCLUDES THE SOFTWARE LICENSE. THIS AGREEMENT CONSTITUTES THE COMPLETE AND EXCLUSIVE AGREEMENT BETWEEN LICENSEE AND ENCORP WITH RESPECT TO THE PRODUCTS INCLUDED WITH THIS AGREEMENT. IF LICENSEE DOES NOT AGREE TO THE TERMS OF THIS AGREEMENT, IT MUST RETURN ALL OF THE PRODUCTS, INCLUDING DISKS, WRITTEN MATERIALS, BINDERS, OR ANY OTHER OBJECTS INCLUDED WITH THE PRODUCT(S) WITHIN THIRTY (30) DAYS AFTER PURCHASE TO ENCORP FOR A FULL REFUND. IN ORDER TO RECEIVE A REFUND, ALL MATERIALS MUST BE IN THEIR ORIGINAL CONDITION.

ENCORP SOFTWARE LICENSE

- 1. GRANT OF LICENSE.** In consideration of payment of the LICENSE fee, which is part of the price LICENSEE paid for the product(s), Encorp, as licensor, grants LICENSEE a nonexclusive right to use and display this copy of the Encorp software program(s), which includes any written materials or documentation thereto (hereinafter "SOFTWARE") on a single computer (i.e. a single CPU) at a single location. The LICENSE granted hereby and the use of the term "PRODUCTS" herein is limited to those systems and/or other products that were purchased by LICENSEE. Encorp reserves all rights not expressly granted to LICENSEE.
- 2. OWNERSHIP OF SOFTWARE.** LICENSEE owns the optical or other physical media on which the SOFTWARE is originally or subsequently recorded or fixed, but Encorp retains all right, title and interest in and to the SOFTWARE recorded on the original disk copy(ies) and all subsequent copies of the SOFTWARE and any and all intellectual property rights therein, regardless of the form of the media in or on which the original and other copies may exist. This LICENSE is not a sale of the original SOFTWARE or any copy. Nothing in this Agreement will be construed as conferring upon LICENSEE or any third party (by implication, operation of law, estoppel, or otherwise) any license or right not expressly granted by Encorp in this Agreement.
- 3. COPY RESTRICTIONS.** This SOFTWARE and the accompanying written materials are copyrighted. Unauthorized copying of the SOFTWARE is expressly prohibited. LICENSEE may be held legally responsible for any copyright infringement that is caused or encouraged by LICENSEE'S failure to abide by the terms of this LICENSE. Subject to these restrictions, and if the SOFTWARE is not copy-protected, LICENSEE may
 - a. Make one (1) copy of the SOFTWARE solely for backup purposes.
 - b. Make one (1) copy only of written materials supplied on electronic media if so supplied for LICENSEE'S use only.
 - d. LICENSEE must reproduce and include the copyright notice on the backup and all other copies.
- 4. USE RESTRICTIONS.** LICENSEE may physically transfer the SOFTWARE from one computer to another provided that the SOFTWARE is used on only one computer at a time. LICENSEE may not electronically transfer the SOFTWARE from one computer to another over a network, except for the purpose of installation. LICENSEE may not distribute copies of the SOFTWARE or accompanying written materials to others. LICENSEE may not modify, adapt, translate, reverse engineer, decompile, disassemble, or create derivative works based on the SOFTWARE. LICENSEE may not modify, adapt, translate, or create derivative works based on documentation provided with the SOFTWARE without the prior written consent of Encorp. LICENSEE agrees to keep confidential and use its best efforts to prevent and protect the SOFTWARE from unauthorized disclosure or use. LICENSEE may not remove the proprietary notices that appear on or in the SOFTWARE.
- 5. TRANSFER RESTRICTIONS.** This SOFTWARE is licensed only to LICENSEE, and may not be transferred to anyone without the prior written agreement of Encorp. Any unauthorized transferee of the SOFTWARE shall be bound by the terms and conditions of this Agreement. In no event may LICENSEE transfer, assign, rent, lease, sell, or otherwise dispose of the SOFTWARE on a temporary or permanent basis except as expressly provided herein.

6. **TERMINATION.** This License is effective until terminated. This License will terminate automatically without notice from Encorp if LICENSEE fails to comply with any provision of this License. Upon termination LICENSEE shall destroy or return to Encorp all copies of the SOFTWARE, if any.
7. **UPDATE POLICY.** Encorp may create, from time to time, updated versions of the SOFTWARE. At its option, Encorp will make such updates available to the LICENSEE and transferees who have paid an update fee to be determined by Encorp in its sole discretion.
8. **CONFIDENTIALITY.** LICENSEE agrees that the SOFTWARE contains proprietary information, including trade secrets, know-how and confidential information, that is the exclusive property of Encorp. During the period this Agreement is in effect and at all times after its termination, LICENSEE and its employees and agents shall maintain the confidentiality of this information and not sell, license, publish, display, distribute, disclose or otherwise make available this information to any third party nor use such information except as authorized by this Agreement. LICENSEE shall not disclose any such proprietary information concerning the SOFTWARE, including any flow charts, logic diagrams, user manuals and screens, to persons not an employee of LICENSEE without the prior written consent of Encorp.
9. **MISCELLANEOUS.** This Agreement is governed by the laws of the State of Colorado.

DISCLAIMER OF WARRANTY AND LIMITED WARRANTY

THE SOFTWARE AND ACCOMPANYING WRITTEN MATERIALS (INCLUDING INSTRUCTIONS FOR USE) ARE GUARANTEED TO PERFORM SUBSTANTIALLY IN ACCORDANCE WITH THE DOCUMENTATION PROVIDED WITH THE SOFTWARE. FURTHER, ENCORP DOES NOT WARRANT, GUARANTEE, OR MAKE ANY REPRESENTATIONS REGARDING THE USE, OR THE RESULTS OF THE USE, OF THE SOFTWARE OR WRITTEN MATERIALS IN TERMS OF CORRECTNESS, ACCURACY, RELIABILITY, CURRENTNESS, OR OTHERWISE. THE ENTIRE RISK AS TO THE RESULTS AND PERFORMANCE OF THE SOFTWARE IS ASSUMED BY LICENSEE. IF THE SOFTWARE OR WRITTEN MATERIALS ARE DEFECTIVE LICENSEE, AND NOT ENCORP, OR ITS DEALERS, DISTRIBUTORS, AGENTS, OR EMPLOYEES, ASSUMES THE ENTIRE COST OF ALL NECESSARY SERVICING, REPAIR, OR CORRECTION.

Encorp warrants to the original LICENSEE that the disk(s) on which the SOFTWARE is recorded is free from defects in materials and workmanship under normal use and service for a period of ninety (90) days from the date of delivery as evidenced by a copy of the receipt. Further, Encorp hereby limits the duration of any implied war-

ranty(ies) on the disk to the periods stated above. Some states do not allow limitations of an implied warranty, so the above information may not apply to LICENSEE.

Encorp's entire liability and LICENSEE'S exclusive remedy as to the disk(s) shall be, at Encorp's option, either (a) return of the purchase price or (b) replacement of the disk that does not meet Encorp's Limited Warranty and which is returned to Encorp with a copy of the receipt within ninety (90) days after date of delivery as evidenced by a copy of the receipt. If failure of the disk has resulted from accident, abuse or misapplication, Encorp shall have no responsibility to replace the disk or refund the purchase price. Any replacement disk will be warranted for the remainder of the original warranty period or ninety (90) days, whichever is longer.

THE ABOVE ARE THE ONLY WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF THE MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT, THAT ARE MADE BY ENCORP ON THE PRODUCTS. NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY ENCORP, ITS DEALERS, DISTRIBUTORS, AGENTS OR EMPLOYEES SHALL CREATE A WARRANTY OR IN ANY WAY INCREASE THE SCOPE OF THIS WARRANTY, AND LICENSEE MAY NOT RELY ON ANY SUCH INFORMATION OR ADVICE. THIS WARRANTY GIVES LICENSEE SPECIFIC LEGAL RIGHTS. LICENSEE MAY HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.

NEITHER ENCORP, NOR ANYONE ELSE WHO HAS BEEN INVOLVED IN THE CREATION, PRODUCTION, OR DELIVERY OF THIS PRODUCT SHALL BE LIABLE FOR ANY DIRECT, OR INDIRECT, CONSEQUENTIAL, OR INCIDENTAL DAMAGES (INCLUDING DAMAGES FOR LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTION, LOSS OF BUSINESS INFORMATION, AND THE LIKE) ARISING OUT OF THE USE OF OR INABILITY TO USE SUCH PRODUCT EVEN IF ENCORP HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
